

## **Acceptable Use Policy**

This acceptable use policy sets out the terms between you and us under which you may access our website [www.samsgutters.net](http://www.samsgutters.net) (our site). This acceptable use policy applies to all users of, and visitors to, our site.

Your use of our site means that you accept, and agree to abide by, all the policies in this acceptable use policy, which supplement our terms of website use <https://samsgutters.net/wp-content/uploads/2022/10/Website-Terms-and-Conditions-071022.pdf>.

[www.samsgutters.net](http://www.samsgutters.net) is a site operated by Sam's Gutters Limited (we or us). We are registered in England and Wales under company number 07581016 and we have our registered office at First Floor Offices, 91 – 93 Lingfield Road, RH19 2EL. Our VAT number is 306555901.

### **Prohibited uses**

You may use our site only for lawful purposes. You may not use our site:

- In any way that breaches any applicable local, national or international law or regulation.
- In any way that is unlawful or fraudulent, or has any unlawful or fraudulent purpose or effect.
- For the purpose of harming or attempting to harm minors in any way.
- To send, knowingly receive, upload, download, use or re-use any material which does not comply with our content standards.

- Be made in breach of any legal duty owed to a third party, such as a contractual duty or a duty of confidence.
- Promote any illegal activity.
- Be threatening, abuse or invade another's privacy, or cause annoyance, inconvenience or needless anxiety.
- Be likely to harass, upset, embarrass, alarm or annoy any other person.
- Be used to impersonate any person, or to misrepresent your identity or affiliation with any person.
- Give the impression that they emanate from us, if this is not the case.
- Advocate, promote or assist any unlawful act such as (by way of example only) copyright infringement or computer misuse.

### **Suspension and termination**

We will determine, in our discretion, whether there has been a breach of this acceptable use policy through your use of our site. When a breach of this policy has occurred, we may take such action as we deem appropriate.

Failure to comply with this acceptable use policy constitutes a material breach of the terms of use of our Acceptable Use Policy upon which you are permitted to use our site, and may result in our taking all or any of the following actions:
